Investment Overview

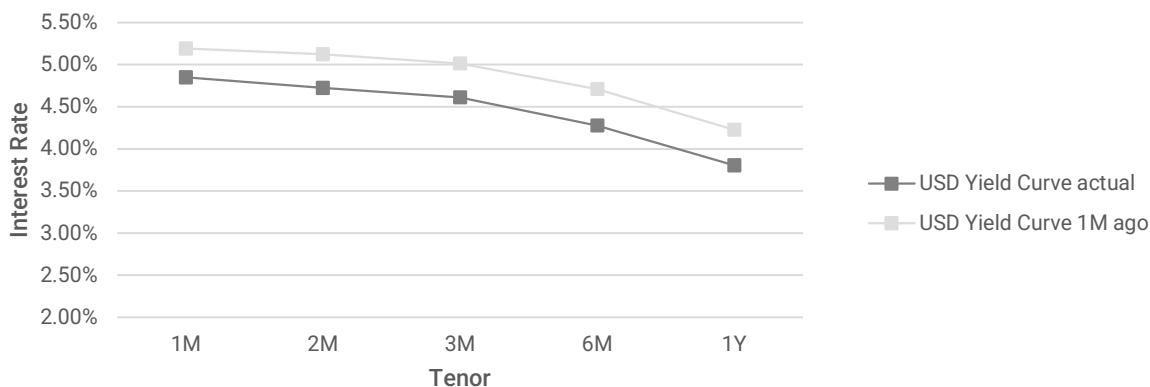

Convexis combines market and issuer analysis to identify those investments that offer the most attractive risk/return profile. The active approach to the administration of investments is based on strict risk controls that are reviewed by an external auditor. Furthermore, investments decisions are following the Placement Guidelines from the Swiss Bankers Association.

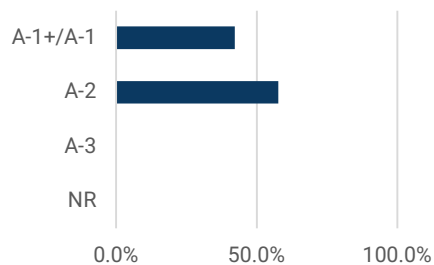

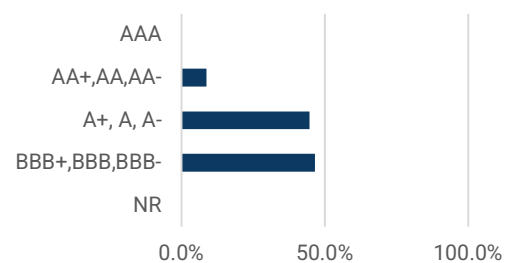

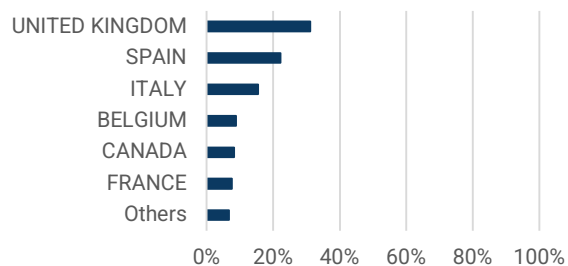
ST Rating breakdown (% of all assets)



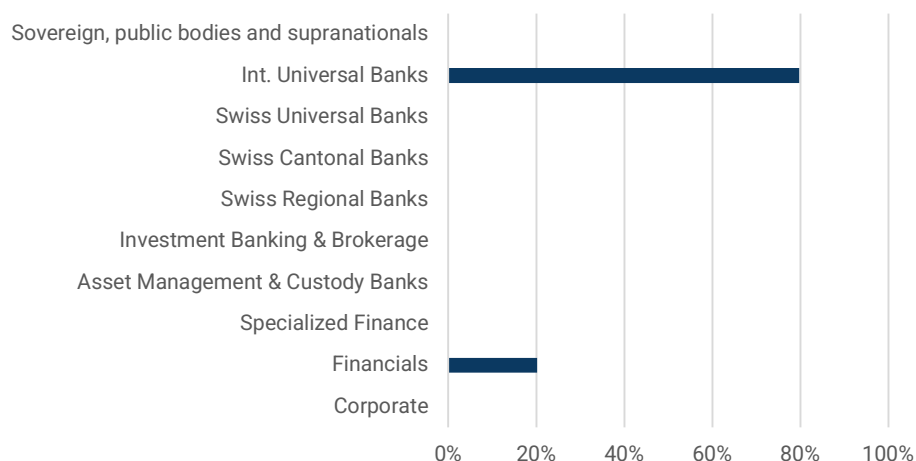
LT Rating breakdown (% of all assets)
